Mr. Peter Hurtgen made an opening statement on behalf of the City Manager regarding his interpretation of what matters could be heard at this session. Mr. Nick Pellegrino spoke as a representative of the City Manager and in support of the City Manager's rejection of the recommendation in the Special Master's report concerning longevity.

Mr. Charles Holley and Mr. Charles Rhoades addressed Council in support of the stand taken by the Fraternal Order of Police regarding the longevity as it has been done.

Mayor Anderson opened the Public Hearing at 11:58 a.m. There being no one to speak for or against, the Mayor closed the Public Hearing at 11:59 a.m. The below titled resolution was submitted to Council for consideration.

A RESOLUTION EXPRESSING THE POSITION OF THE CITY OF NAPLES WITH REGARD TO THE SPECIAL MASTER'S FINDINGS OF FACT AND RECOMMENDATIONS RELATING TO THE FRATERNAL ORDER OF POLICE, AND RESCINDING ALL RESOLUTIONS OR PARTS THEREOF IN CONFLICT HEREWITH TO THE EXTENT OF SUCH CONFLICT.

After further discussion it was the consensus of Council: to transpose the sentences in Section 1, Part C to read "The Public Employer reserves the right to schedule compulsory overtime when necessary to complete the police mission. Overtime shall be assigned at the discretion of the department head."; to add the word "longevity" after the word "merit" in the seventh paragraph of page 2; to add the word "merit" before "longevity" in the tenth paragraph of page 2; and to delete the words "expressing the position" from the title. Mr. Twerdahl moved to adopt Resolution 3135 as amended, seconded by Mr. Schroeder and carried on roll call vote, 7-0.

There being no further business to come before this Special Meeting of the Naples City Council, Mayor Anderson adjourned the meeting at 12:25 p.m.
