CONSIDER AND SET THE PROPOSED MILLAGE RATE FOR 1985 TAXES

Mayor Billick explained that Mr. Barnett was out of town and Mr. Richardson was recuperating from knee surgery. City Manager Jones reviewed the information in his memorandum dated July 30, 1985, and recommended that Council approve a total millage rate of 1.2294. He explained that this was the rollback rate which would generate the same amount of revenue from ad valorem taxes this year as was generated last year, taking in account the increased evaluations. He further noted that this recommended rate was approximately 8% lower than the 1.2591 rate used last year. He explained that the 1.2294 was a total of 1.1605 proposed rate plus .0689 for debt service.

MOTION: To APPROVE setting the proposed millage rate at 1.2294.

City Manager Jones suggested beginning the Budget Workshops on Tuesday, August 6, 1985 and tentatively scheduling two more meetings on the ensuing Tuesdays. He further suggested that the first evening Public Hearing be held on Wednesday, September 4th at 5:30 p.m. It was the consensus of Council to concur with this schedule.
