BY THE GULF COAST SAILING CLUB, A NON-PROFIT CORPORATION, OR THEIR AUTHORIZED AGENT, AT THEIR AWARDS PRESENTATION FOR THEIR ANNUAL CHARITABLE REGATTA TO BENEFIT THE CONSERVANCY, INC.; AND PROVIDING AN EFFECTIVE DATE.

This special use permit would not require Council's approval, he further pointed out. Mayor Putzell asked what type of demands would be made upon the City's police and fire departments and the City Manager advised that this type of event would indeed require extensive use of both departments.

Mayor Putzell asked staff to prepare a report of this event's activities and any recommendations for future events.

City Manager Jones pointed out that several years ago, at a Council workshop meeting, the staff had prepared an ordinance which would codify some of the City's policies and procedures; however, it was


