A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF NAPLES EXPRESSING SUPPORT FOR A  
ONE CENT LOCAL OPTION SALES TAX WITHOUT  
REFERENDUM; AND PROVIDING AN EFFECTIVE  
DATE.

Title read by City Attorney Rynders.

City Manager Jones explained that this resolution was presented as a request from the Florida League of Cities. Passage of this resolution, he said, would demonstrate the City's supporting legislation for a one cent local option sales tax without referendum. This plan is to enable cities and counties experiencing large growth impacts to enact a local tax which would meet their infrastructure needs.

Mayor Putzell suggested that a cover letter by a City official be included with true copies of the resolution sent to the appropriate government agencies.

Mr. Richardson said that he was impressed with the government in Tallahassee as they seemed interested in the views of city officials. It is estimated, he said, that this increase would provide approximately \$16-million per year to Collier County.
