

ITEM 1

REVIEW OF COMPREHENSIVE PLAN IN LIGHT OF COMMENTS FROM THE FLORIDA DEPARTMENT OF COMMUNITY AFFAIRS.

Community Development Director McKim presented each member of Council with the Department of Community Affairs' (DCA) comments and a reference list indicating where that particular item could be found in the Plan (a copy of which can be reviewed from the meeting packet in the City Clerk's Office).

After a brief discussion regarding DCA comments, Mrs. McKim explained that Council would receive the Planning Advisory Board's (PAB) recommendations after its final public hearing to be held this evening. Council will then hold its first public hearing on the Comprehensive Plan December 14, 1988, she said.

Councilman Muenzer asked if the City could ask for an extension should it find the PAB cannot address all remaining issues at its next meeting. City Attorney Rynders pointed out that such a request has not been tested in the Courts, but if the City were to recommend a certain action which could adversely affect a land owner, it is possible that its adopted Plan policies might be tested and perhaps even overruled by the Court. State law mandates that these Growth Management Plans must be filed within the deadline, he said.

Among the recommendations included in the preliminary report of the R/UDAT Community Institutions Task Force under the chairmanship of John Passidomo was an assessment of the cultural needs of the citizens of our community and the formation of a cultural affairs council that would adopt and implement a cultural action plan to serve those needs.

A sub-group of the Community Institutions Task Force has undertaken this responsibility and I have joined as its chairman.

It is the group's intention that the proposed council be devoted to the support and promotion of cultural affairs, in the broad meaning of the term, and that the entire community be given the opportunity to participate in defining the area's needs upon which will be based the specifics of the council's work.

We have solicited and received the attached proposal from Kenneth R. Kahn who is the executive director of the Metropolitan Dade County Cultural Affairs Council. We have met with Mr. Kahn and reviewed his credentials. We are confident that he would do an excellent job and would like to hire him as consultant.

We feel sure that you agree with us that such a council as the R/UDAT task force recommended would be an asset to the people of Collier County in that it would serve to enhance the quality of life here. Therefore, I am writing to ask whether the City Council and County Commission would be willing to fund Mr. Kahn's fee on a 50-50 basis.

If you have any suggestions or questions, we would be glad to hear them! Otherwise, may we have an answer at your earliest convenience regarding our request?

Work Outline: A Process for Cultural Needs Assessment Leading to the Formation of a Cultural Affairs Council for Greater Naples

Scope of Services

Consultant will design a needs assessment and cultural planning process and lead in person a series of approximately seven public forums to result in recommendations by Spring of 1989 leading to the formation of a Greater Naples Cultural Affairs Council to support and promote the arts. Beyond leading the cultural planning forums, consultant will meet with the appropriate public officials and private sector individuals in order to help secure adequate funding for this Council and its personnel and operations.

Proposed Timetable

The following schedule outlines a series of "Greater Naples Monday Night Cultural Forums" held every two weeks. These meetings are formulated to produce a cultural needs assessment of the Greater Naples area and designed to lead to the formation of an appropriately structured and funded Cultural Affairs Council.

October 17, 1988	Introduction and General Assessment of the Scope of Cultural Activities and Community Concerns (i.e., "Get-Acquainted" Session with the Community's Cultural Representatives)	
October 31, 1988	Visual Arts and Crafts Organizations, Artists and Galleries

November 28, 1988	Historical, Preservation and Science Groups, Parks and Recreation, Festivals and Special Events	
December 12, 1988	Business and Tourism Interests and Service and Civic Organizations	
January 9, 1989	Government and Education	
January 23, 1989	Media Representatives and Wrap-up and Round-up General Session of Cultural Constituents
