That basically is a very quiet neighborhood, he said, and such an increase in traffic would disrupt this. Mr. Muenzer then asked what was planned for a commercial site on the west side of Goodlette-Frank Road. Mr. Barry explained that they have not considered any plans for that property but, supposed it would be something permitted in the Highway Commercial (HC) zone. City Attorney Rynders asked the group what it wanted from Council at this meeting. Mr. Barry responded that he had hoped to answer any questions it might have and through the Planning Advisory Board (PAB) hearings it could continue to refine the project. The only concern verbalized from Council was that of possible traffic impacts upon 12th and 14th Streets and asked Mr. Barry's group to provide more information about the proposed impacts.
