	Mayor Putzell thanked everyone present for attending and reminded the audience that Neighborhood Town Meetings are a part of the City's People to People program. He also acknowledged City Manager Frank Jones and City staff members in attendance.						r.
	The Mayor announced that the survey recently conducted by Fraser & Mohlke Associates, Inc., showed that 75% of the residents interviewed felt City government was efficiently run. The survey also indicated that the City's "open-door policy" has met with considerable success and that its citizens were happy with the financial condition of the City.

	City Manager Jones expressed his appreciation to the City staff, Mayor Putzell, and Council for their professionalism and dedication.						
	With reference to the recent annexation of additional territory (Seagate and the northern area of Park Shore), Mr. Jones said the City has been able to meet service commitments at no additional cost to other City residents. Additional Police personnel, he said, enables officers to be responsible for smaller areas. In addition,

another rescue unit has been added to the Fire Department, providing better coverage and faster response time.				e e		
Manager Jones reported that the beach parking areas on northern Gulf Shore Boulevard have been assimilated into the City's beach parking program, meters have been installed, and the City is providing patrol and maintenance.						

Mayor Putzell summarized several issues of great importance to the City's future, including proper planning, a need to address the drug problem, provision of affordable housing, the pros and cons of annexation, potable water supplies, concern for the environment and worsening traffic conditions. He also stressed the importance of educational opportunities and increased cultural assets.

A resident thanked the Mayor for reviewing the City's activities and asked several questions about future plans for the Seagate area. His concerns included the traffic at the intersection of Crayton Road and Seagate Drive and landscaping at the end of Gulf Shore Boulevard North. Mr. Jones explained that Seagate Drive is under the County's jurisdiction but there are, however, plans to rectify the traffic flow problem in that area.						

In response to a question from the audience, Mr. Jones gave a breakdown of the number of people employed in each department. Thirty-two new employees were hired during 1989, due to annexation and expansion.
