City Manager Woodruff explained that because of scheduling, staff was unable to participate in this project. The only prudent alternative was to utilize the professional service proposal of Wilson, Miller, Barton and Peek. Staff recommended continuing with their contract.

Engineering Manager Leighton Westlake answered Council's questions about the project. Wilson, Miller, Barton and Peek were involved in the initial permitting on the project. If another firm were to be hired, the entire permit would have to be redone, he said.

The City Manager told Council that staff was capable of doing this work, however, because of involvement in other projects at this time, there simply was not enough time available to meet the time constraints.

Dockmaster Nick Long said that he had contacted two other firms and that Wilson, Miller, Barton and Peek were the best choice as far as price and the timeframe involved.
