Although the City has a number of headwalls and one large drain on the lake, the lake is private. Dr. Staiger informed Council that the permitted revetment will stabilize the shoreline in its present position and earth fill will not be placed to advance the shoreline into the lake. A turbidity curtain or screen must be employed during the excavation and construction to prevent silt from spreading into the lake.

#### **RESOLUTION NO. 92-6825**

**ITEM 12** 

A RESOLUTION AUTHORIZING THE CITY MANGER TO MAKE APPLICATION FOR PERMITS TO ERECT SIGNS RESTRICTING FISHING IN MAN-MADE SALT WATER CANALS IN THE CITY OF NAPLES; AND PROVIDING FOR AN EFFECTIVE DATE.

Title read by City Attorney Chiaro.

City Manager Woodruff reported that Captain Moses Jordan, Department of Natural Resources (DNR) had requested that Council pass specific legislation authorizing the City Manager to apply for permits to erect signs restricting fishing in the man-made salt water canals within the City. After approval by Council, Captain Jordan will submit the permits to his agency for approval.

The City's original intent, said Dr. Staiger, was to post 35 signs, however, the State is may require 105 signs, making this a very expensive process. Engineering Manager Leighton Westlake further described the signs and answered Council's questions. Mr. Westlake assured Council that staff intended to continue its original request for 35 signs.

Dr. Staiger commented that, in his opinion, the local bill which established the ban on net fishing would never be modified. Although this bill had been appealed, the judges believed the signs should be posted. City Attorney Chiaro told Council, "The question of maximum protection goes to the issue of whether we are going to be able to support the citations that are issued. With all of the signs as suggested, that certainly is our best posture when our officers go in and testify that they cited the fishermen." When the signs are posted, she added, there can be no question whether the fishermen are informed. Council Member Korest voiced his support for this action, noting that the Marine

Patrol needed to be able to enforce the ban.

# **Captain Frank Gumpert, 5146 Kristin Court**

Mr. Gumpert read a letter he had written to Council (Attachment #1). He also quoted from a December 15, 1992 Naples Daily News article, which stated: "Southwest Florida is flooded with commercial fishermen during the roe season because it is the last region in the State where fish lay their eggs. Up to 75% of mullet roe caught every year in the State comes from this region."

Dr. Staiger addressed one issue that was raised, stating, "This is not a local ordinance. This is a law of the State of Florida. It is a law passed by the Legislature. It is not legal for cities or counties to regulate fishing; it has to be done by either the Marine Fisheries Commission or the Legislature. Neither Leighton (Westlake) nor I want to be charged with a misdemeanor under the Florida law that regulates placing signs in waterways and I don't care what the County did. There is a State law that regulates signage and if you disobey the law you can get....it's a misdemeanor. You get arrested by the Marine Patrol for the process, therefore, we're going through it in this manner."

#### **RESOLUTION NO. 92-6826**

ITEM 7

A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A CONCURRENCY INTERLOCAL AGREEMENT BETWEEN COLLIER COUNTY AND THE CITY OF NAPLES; AND PROVIDING AN EFFECTIVE DATE.

Title read by City Attorney Chiaro.

City Manager Woodruff emphasized that this Interlocal Agreement established cooperation between the City and the County on concurrency issues. It does not set any moratorium.

Metropolitan Planning Organization (MPO) Coordinator Jeff Perry addressed Council and answered questions about the Agreement. He explained that should a level of service fall below an acceptable standard, then a land moratorium can be placed both inside and outside the City on those developments that would impact that roadway system. Mr. Perry said that the City, through its annual analysis, would determine whether any deficient conditions existed, then the moratorium process would begin.

Mr. Perry described the analysis of the Gordon River Bridge which had been done using the MPO's process. Presently, there are no level of service problems, however, there may be in the future, depending on where development occurs along Golden Gate Parkway. Timing of any road improvements is dependent upon the growth of the area. Council Member Herms said, "The only option for elected officials is to reduce the land use patterns. The City and County have to work cooperatively." Mr. Herms stated that, in his opinion, discussion of land use and concurrency issues should be held at a televised meeting, rather than at a workshop session.

### ORDINANCE NO. 92-6830

ITEM 8

AN ORDINANCE DELETING SUBSECTIONS 5-7-8(A) (1) AND (2) OF THE COMPREHENSIVE DEVELOPMENT CODE; ADDING NEW SUBSECTIONS 5-7-8(A) (1), (2) AND (3) TO THE COMPREHENSIVE DEVELOPMENT CODE TO REVISE THE EXISTING IRRIGATION SCHEDULE TO INCLUDE ALL AREAS OF THE CITY OF NAPLES; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

Title read by City Attorney Chiaro.

City Manager Woodruff reviewed the ordinance and changes to language as requested by Council at the December 14th Workshop. Council Member Pennington requested that Section 1(A)(4) be amended to read as follows: "Irrigation of newly planted landscape shall be exempted from these restrictions for the first thirty (30) days after planting." At Mr. Pennington's request, staff will provide information showing where increased water usage is occurring.

Council Member Korest emphasized that the City should investigate and encourage the use of water conservation devices such as moisture sensing. He noted that most people watered their lawns more than was necessary and steps could be taken to considerably reduce water consumption.

Vice Mayor Sullivan referred to a letter from the Greater Naples Civic Association addressed to Council dated December 14, 1992 (Attachment #2). The letter asked several questions with respect to water conservation and the involvement of the South Florida Water Management District. Mr. Sullivan requested that staff review the questions posed in the Civic Association's letter and provide the answers to Council. He also asked that staff research water usage at the Golden Gate wellfield over a period of time and report whether water usage is down this time of year.

**Brad Estes, 378 Goodlette Road South** 

Mr. Estes thanked Council for acknowledging the Civic Association's letter. Referring to the South Florida Water Management District, Mr. Estes asked, "Is this an issue of political clout, or what is our allocation going to be? Is there a problem with the Golden Gate wellfield?" Mr. Estes told Council that the Association supported any responsible use of water but believed that the issue in this case was waste.

**MOTION:** To **ADOPT** the ordinance at second reading with the changes to the language in Section 1 (A)(4) as stated above.

Council Member Herms suggested transmitting information to City residents with respect to water conservation devices. City Manager Woodruff reported that Mike Slayton of the South Florida Water Management District had donated samples of such devices to the City. Staff will report on the devices and their prices.
