ITEM 3

A RESOLUTION AUTHORIZING THE USE OF THE COLLIER COUNTY COMPUTER ELECTION SYSTEM FOR THE GENERAL MUNICIPAL ELECTION TO BE HELD ON FEBRUARY 1, 1994; APPROVING THE FORM AND CONTENT OF THE BALLOT FOR SAID ELECTION; AND PROVIDING AN EFFECTIVE DATE.

Title read by City Attorney Chiaro.

City Clerk Janet Cason reviewed the resolution and informed Council that the ballot for one precinct (Park Shore Units 2 and 5) would include the question: Authorization to amend the application of funds from the Park Shore Special Taxing District and to consolidate the District with the Moorings Bay System Special Taxing District.

Responding to Mayor Muenzer's request, Mrs. Cason said that State law requires the City to include provisions for a qualified write-in candidate on the ballot.

One of the candidates is a City employee. City Attorney Chiaro explained that under the Florida Statutes, that person is not required to resign his City position in order to run for office. However, if he is elected, under nepotism laws he will be required to resign.

City Clerk Cason announced that another candidate is a resident of the newly annexed area, Bear's Paw. Attorney David Cardwell, who has been retained by the City to oversee the election procedure, has notified Mrs. Cason that the candidate fulfills the residency requirement. (A letter supporting this question is included in these minutes as Attachment #1.)
