- 3. On street parking on Sixth Avenue South, in the area of Tin City. Staff and Tin City representatives reviewed a conceptual plan for angled right-of-way parking, signage, landscaping and lighting improvements to the general area of Tin City and Dockside Boardwalk. More detailed plans will be prepared, including information on funding.
- 4. Solid waste/horticultural alternatives and land acquisition. (Community Services) Staff will pursue appraisal of property offered for sale by John Pulling; staff will review with President's Council (city property owner associations) at the group's May meeting the proposed use of "Toter" can lifts for collection of bagged horticultural material.
- 5. Discussion of items on May 4, 1994, Special Meeting agenda adoption of Redevelopment Plan. City Council Members noted the following requested amendments: Prolman-eliminate the word "although" from last sentence on Page 31 with reference to building heights; Korest-include in "Environmental Objective" on Page 11 language which requires design work to be coordinated with "safety through environmental protection" concepts; Muenzer-remove references to study of roundabout at Four Corners on Page 39; Muenzer-remove specific reference to Tenth Street regarding flooding and storm water management on Page 46; Muenzer-requested removal of specific location regarding the residential area north of Naples Community Hospital.
