Comprehensive Plan - Department of Community Affairs Objections, Recommendations and Comments (ORC) Report – *It was the consensus of Council to include a non-committal statement in the text portion stating that the City would explore the possibility of a second Gordon River Bridge. (MacKenzie and Tarrant dissenting)

8. Review of items on the 11/19/97 Regular Meeting Agenda
Item 5g (Purchase order for tennis court lights at Naples High School) Vice Mayor Prolman requested this item be scheduled for separate discussion.
Item 9 (Bid award for trimming City-owned palm trees) Council Member MacKenzie requested information regarding the Collier County offices of Environmental Care
9. Diamond Jubilee Update *(Requested by Council Member MacKenzie)* – ***Council Member MacKenzie requested the report be delivered at the 11/19/97 Regular Meeting.***
10. Tom Reed - Coconut Grove Boat Issue – ***It was the Consensus of Council to consider this issue as the first item of business at the Regular Meeting of 11/19/97.***

Correspondence / Communications – Council Member Tarrant referred to a letter to Council regarding City Attorney Kenneth Cuyler's acceptance as interim City Attorney to the new City of Marco Island. Mr. Tarrant expressed concern as to the appropriateness of Attorney Cuyler serving another city in the event of conflicts of interest. It was the consensus of Council not to object to Attorney Cuyler acting as interim attorney for the City of Marco Island.

Open Public Input - At conclusion of agenda items 15 minute maximum (3 minutes per person) - Bruce D'Elia distributed a complaint letter to Council regarding the bid award for City palm tree trimming. Mayor Barnett advised that the issue would be dealt with during the 11/19/97 Regular Meeting. Everett Thayer said he was concerned about the city's annexation of property on North Road, and Council Member MacKenzie explained that this was done to avoid having two jurisdictions maintaining the road. James Shucart stated that the City should honor the zoning that was in effect when he purchased a condominium building on Gulf Shore Boulevard. Peter Gerbosi expressed the Gulf Shore Boulevard Property Owners support of Council's decision to maintain the current comprehensive plan for low-rise buildings in Coquina Sands and the Moorings. Further, he urged Council to set hurricane standards to protect property from hurricanes making landfall from the west. Virginia Corkran reviewed corrections to the Comprehensive Plan and concurred with Council Member Nocera's suggestion for a fund to acquire open space.
