1. Roll call – *Vice Mayor Prolman and Council Member Nocera arrived at 8:31 a.m. Community Services Advisory Board Member Russell was absent. Planning Advisory Board Members Rideoutte, Asher and Hole were absent.*

3. Fire Operations - Overview of Safety Patrol Program – *Police Chief Kevin Rambosk described the functions of the new Fire Rescue Public Safety Bicycle Patrol Program and firefighters Rob Henzmann, Michael Leal, and Pete DiMaria demonstrated the emergency bicycle equipment.*
4. Review of items on the 12/3/97 Regular Meeting Agenda -
Item 5g & Item 5h – (Discussion regarding procurement of irrigation system installation and streamlining the bid procedures) Vice Mayor Prolman requested these items be removed from the Consent Agenda for separate discussion.
Item 5c – (Authorization of agreement with the Naples Airport Authority for airport emergency services) Council Member MacKenzie requested this item be removed from the Consent Agenda for separate discussion.
Items 8a & 8b (Consider combination of lots in the Green Dolphin Section of Port Royal) These items will be continued.
Item 12 – (Settlement of a lawsuit) City Manager Woodruff requested this items be added to the agenda.

5. Joint discussions with the Community Services Advisory Board regarding the proposed Master Plan for Cambier Park Redevelopment Phase II – *Consensus decisions were: CSAB Members agreed to eliminate a water feature(DePasquale dissenting) Council Members agreed to eliminate a water feature (Sullivan absent, Tarrant dissenting) Council Members agreed that the three major park entryways should be landscaped rather than feature a building/structure entryway. CSAB Members expressed a preference for serpentine walkways. Council Members expressed a preference for serpentine walkways (Tarrant dissenting) Council Members agreed to relocate the pavilion/gazebo.*

6. Discussion regarding Central Avenue median – *It was the consensus of Council to review the issue at the 1/5/98 Workshop Meeting with alternative designs to be presented by Development Services Director Richard Gatti.*
7. Joint discussions with the Planning Advisory Board relating to proposed sign code amendments – *Planner Flinn Fagg presented the proposed changes to the sign ordinance pertaining to four zoning districts in the City. Council Member MacKenzie requested clarifications on the definition of banners, and Vice Mayor Prolman urged zoning regulations applicable to neon signs.*
8. Appointment to the Airport Noise Compatibility Committee – *Council Member Nocera was unanimously selected for appointment to the Airport Noise Compatibility Committee.*
