Correspondence and Communications – Council Member Tarrant requested consideration for including an agenda item relating to year-round horse and carriage operations. City Manager Woodruff will supply details from the record regarding Council's prior decision in order for Council to revisit the issue.

Council Member Coyle requested a staff proposal to restrict the height of all buildings to 35 feet in the C2-A Waterfront Zoning District in order to include boat storage buildings. City Manager Woodruff said that staff would initiate the ordinance process regarding building height and setback standards that would ultimately come before Council for final approval.

Vice Mayor MacKenzie noted that Brittany Condominium residents have applied for a variance in order to continue lighting the top floors of the building. Therefore, the lights will remain on until the variance process is completed.

Council Member Herms requested no smoking signs for the Cambier Park Playground. City Manager Woodruff reported that signs were already on order and receptacles will be placed in the area. In addition, a determination would be made to clarify whether the State law permits a municipality to declare a smoke-free area outdoors.

Mayor Barnett said Council Member suggestions for handling the 18 applications for City Attorney should be forwarded to the City Manager.
