Correspondence and Communications

City Attorney Kenneth Cuyler was directed to continue work on the language for the second Gordon River Bridge funding ballot question. Council Member Herms stated that the Old Naples Association asked that the Old Naples and Aqualane Shores boundaries as reflected in the Comprehensive Plan, be researched as their accuracy was in question. Mr. Herms announced a day which was established to commemorate George Washington, and he noted a request for a proclamation and planting of a tree on April 30th in Cambier Park; Council concurred. Mr. Herms also requested a copy of the stormwater budget and a revenue/expenditure history. He then made a motion (seconded by Council Member Tarrant) to proceed with the rezoning of the west quadrant of the airport from "C-4" Airport Commercial District to "C" Conservation. After a brief discussion, Council decided instead to table

this motion (made by Vice Mayor MacKenzie, seconded by Council Member Van Arsdale with Council Members Coyle, Herms, and Tarrant dissenting). He then made a motion (seconded by Council Member Tarrant) to place on a future agenda the rezoning of the Airport Authority's property along the bay currently zoned "R1-7.5" Residence District to "C" Conservation; after a brief discussion he altered his motion to reflect that the City would be the petitioner. There was a full consensus of Council. City Manager Richard Woodruff stated that Michelbob's, the restaurant that provided the meals for the recent Bonfire event, has donated \$4,830.00 to the bandshell fund. Council Member Nocera referred to discussions at the prior Town Hall Meeting regarding conditions at the corner of Davis Boulevard and U.S. 41 and suggested contacting Senator Burt Saunders and Representative Dudley Goodlette for their assistance. Council Member Van Arsdale referred to comments made by public speaker Jim Dean and requested Council input concerning the alleged infractions committed by one of its board members; Dr. Woodruff stated that he would research the attendance history of one of the other members Mr. Dean had mentioned.

Open Public Input -

Bob Brady, 2234 Gulf Shore Boulevard North, was not present when called to speak.

Amy Rego, 1060 Sixth Street South, Old Naples Association President, stated that a draft report produced by the Old Naples Task Force identifies Mary Brett incorrectly as the Old Naples Association President. She stressed that the report does not represent the work of the current Old Naples Association and asked that its name therefore be removed.

Jim Dean, 1320 28th Avenue North, stated that he believed the complaints leveled against Heaven, the cigar bar which received a waiver from the 500-foot alcohol beverage requirement, were largely unfounded.

Mr. Dean also stated that he felt Council should look closely at the new board member candidates as well as those requesting reappointment; he maintained that those in office should be good citizens and commented on what he felt was poor behavior of the part of some members including one who has had liens assessed for code violations.
