If a marina of the intensity equal to or exceeding the Development of Regional Impact threshold as set forth in Chapter 380 Florida Statures is requested, then the City would welcome and would require the filing of a DRI Application simultaneously with the application for a conditional use so that the City will have the maximum benefit of information from regional and state agencies. Any application would be reviewed under
