Consider amending Article IV of Chapter 78 of the Code of Ordinances in order to revise regulations pertaining to the operation of charter boats. ***INSTRUCT STAFF to proceed conceptually with the elimination of portions of Article IV of Chapter 78, retaining the temporary unrestricted charter boat classification for displaced unrestricted captains and their boats, retaining a procedure whereby a temporary use permit could be obtained more frequently than twice per year, immediately cease issuing restricted licenses upon adoption of the ordinance, and provide for a reasonable period of time to sunset the restricted charter boat licenses / Wiseman / Galleberg / 5-2 (Herms and Taylor dissenting)***
