LEE; AUTHORIZING THE MAYOR TO EXECUTE THE EMPLOYMENT AGREEMENT; AND PROVIDING AN EFFECTIVE DATE. Title read by City Attorney Robert Pritt prior to the motion of approval (See Page 2). Dr. Robert Lee, City Manager designee, said that he was honored to accepte accept the position and was looking forward to the challenge. He then provided a letter requesting an adjustment of the base pay mentioned in the employment agreement. (Copies of this letter and the referenced agreement are contained in the file for this meeting in the City Clerk's Office.) Dr. Lee said that he had anticipated a salary offer in the mid-range of the advertised figures in light of his current compensation package and past experience. He however proposed a compromise consisting of an increase of \$400 per month base salary effective with the contract start date and an additional \$400 per month upon a completion of six months' service and a successful performance evaluation. In conclusion, Dr. Lee said he is thrilled to have this opportunity and assured Council that he would do the best job possible.

Mayor MacKenzie asked whether Dr. Lee was satisfied with the other terms and conditions of the contract. Dr. Lee said that he was with the exception of the provision regarding the possibility of his scheduling adjunct teaching.
