Correspondence and Communications - Requested that Council receive a daily update on fire calls similar to that of police, and re-establish Comprehensive Plan sections in light of defeat of Amendment 4 (Saad); requested Steve Harrison (County Productivity Committee) and/or Michael Sheffield to join upcoming session with County staff (Winona Stone) on benchmarking and efficiency (Finlay); request for information on cost waiving in conjunction with "Open Air Farmers' Market," need for City efficiency equipment, and need to address communications with Naples Airport Authority/NAA and its disbanding of Technical Advisory Committee (Price); need for stricter deadlines for submittals by petitioners who press Council for expedited approvals, and request for separate budget for River Park Pool, recognized Mayor on his 70th birthday (Heitmann); complimented voters on large turnout (57.7%), recommendation that voters take care to complete and execute absentee ballots carefully, Big Cypress Basin Board to make Naples Bay its priority with regard to diverting fresh water flow for coming year, suggestion for expedited workshop discussion of disbanding of Technical Advisory Committee (Sorev): and recommended that men on Council wear business/casual attire, concurrence with proposed discussions with NAA and need for overall improvement in communications, and request for Council support on approaching State Legislative Delegation to allow banning of smoking on beaches by local jurisdiction (Barnett).
