The CIP projects revenues for each of the City's funds, projects operating expenditures, and determines availability of funds for replacement of capital equipment and infrastructure improvements. These include: vehicles and construction equipment, water and sewer utility projects, landscaping, park improvements, storm drainage improvements, firefighting equipment, buildings, street resurfacing, etc. The upcoming proposed Fiscal Year 2012-13 budget will incorporate the first year of the Five-Year CIP. Presentations will summarize proposed expenditures for each department. Additionally, City Council will discuss a tentative millage rate to be used to calculate property taxes for the year 2012, and an overall General Fund budget strategy.
