FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

THIS FIRST AMENDMENT (the "First Amendment") to the Professional Services Agreement is made and entered into this 19th day of March, 2003, by and between the CITY OF NAPLES, a Florida Municipal Corporation (the "City"), and **Civic Design Associates, 75 NE 6th Avenue, Suite 215, Delray Beach, FL 33483** (the Contractor).

WITNESSETH

WHEREAS, the City and the Contractor entered into that certain Agreement dated June 19, 2002 (the "Original Agreement") for the City's Planning Department, for services associated with The Heart of Naples zoning ordinance ('Project'); and

WHEREAS, the parties desire to amend the Original Agreement by this First Amendment so that the Contractor will provide additional services pursuant to the terms and conditions contained herein.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in consideration of the mutual covenants, promises and conditions herein set forth, it is hereby acknowledged and agreed as follows:

- 1. The above recitals are true and correct and are incorporated herein by this Reference.
- 2. Article One, 1.1 shall be amended in accordance with Exhibit "A" attached hereto and incorporated herein for the provision of additional services by the Contractor **for Phase V of the project (participation in the public hearing process).**
- 3. Article Three, 3.1 shall be amended to reflect a completion date **not-later-than December 31, 2003**
- 4. Article Four, 4.1 shall be amended to add compensation for **Phase V in a not-to-exceed amount of \$6,000.**
- 5. The terms of this First Amendment shall control and take precedence over any and all terms, provisions and conditions of Original Agreement which might vary, contradict or otherwise be inconsistent with the terms and conditions hereof. All of the other terms, provisions and conditions of Original Agreement, except as expressly amended and modified by this First Amendment, shall remain unchanged and are hereby ratified and confirmed and shall remain in full force and effect.
- 6. This First Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same instrument.
