THIRD AMENDMENT TO CONSULTING SERVICES AGREEMENT

THIS THIRD AMENDMENT (the "THIRD Amendment") to the Consulting Agreement is made and entered into this 16th day of August, 2006 by and between the CITY OF NAPLES, a Florida Municipal Corporation (the "City"), and Capri Engineering LLC. (the "Consultant").

WITNESSETH

WHEREAS, the City and the Consultant entered into that certain Agreement to furnish **Professional Engineering Services dated the 7th day of December , 2005 (Res. # 05-11034)** (the "Original Agreement") to the City's Community Development Department for services associated with plan examination and code compliance inspector services ('Project'); and

WHEREAS, the parties desire to amend the Original Agreement by this Third Amendment so that the Consultant will provide additional services pursuant to the terms and conditions contained herein.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in consideration of the mutual covenants, promises and conditions herein set forth, it is hereby acknowledged and agreed as follows:

- 1. The above recitals are true and correct and are incorporated herein by this Reference.
- 2. The scope of services shall be amended in accordance with Exhibit "A" attached hereto and incorporated herein for the provision of additional services by the Consultant in an amount not-to-exceed \$35,000.00 in order to continue professional inspector services for the City of Naples Community Development Department ('Project').
- 3. The terms of this Third Amendment shall control and take precedence over any and all terms, provisions and conditions of Original Agreement which might vary, contradict or otherwise be inconsistent with the terms and conditions hereof. All of the other terms, provisions and conditions of Original Agreement, except as expressly amended and modified by this THIRD Amendment, shall remain unchanged and are hereby ratified and confirmed and shall remain in full force and effect.
- 4. This Third Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same instrument.
