FIRST AMENDMENT TO PURCHASE AND SALE OF GOODS AGREEMENT

THIS FIRST AMENDMENT (the "First Amendment") to Purchase and Sale of Goods Agreement is made and entered into this 16th day of August, 2006 by and between the CITY OF NAPLES, a Florida Municipal Corporation (the "City"), and Evans Oil Company, Inc. (the "Contractor").

WITNESSETH

WHEREAS, the City and the Contractor entered into that certain Agreement dated October 20, 2004, that City Council by Resolution 04-10617, approved with Evans Oil Company, Inc. for the purchase of gasoline and diesel fuel expiring on September 30, 2005, with the option of two one-year renewal periods. (the "Original Agreement") for the City of Naples ('Project'); and

WHEREAS, the parties desire to amend the Original Agreement by this First Amendment so that the Contractor will provide additional services pursuant to the terms and conditions contained herein.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in consideration of the mutual covenants, promises and conditions herein set forth, it is hereby acknowledged and agreed as follows:

- 1. The above recitals are true and correct and are incorporated herein by this Reference.
- 2. The scope of services shall be amended in accordance with Exhibit "A" attached hereto and incorporated herein for the provision of additional services by the Contractor for the purchase of additional gasoline and diesel fuel for the City of Naples in an amount of \$261,503.00 and extending the Agreement Period for FY 2005/06 (the 'Project').
- 3. The terms of this First Amendment shall control and take precedence over any and all terms, provisions and conditions of Original Agreement which might vary, contradict or otherwise be inconsistent with the terms and conditions hereof. All of the other terms, provisions and conditions of Original Agreement, except as expressly amended and modified by this First Amendment, shall remain unchanged and are hereby ratified and confirmed and shall remain in full force and effect.
- 4. This First Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same
