FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT (the "First Amendment") to Agreement is made and entered into this **14th day of November, 2007** by and between the CITY OF NAPLES, a Florida Municipal Corporation (the "City"), and **TLC Lawn Maintenance** (the "Contractor").

WITNESSETH

WHEREAS, the City and the Contractor entered into that certain Agreement to furnish Professional Services dated 19th day of September, 2007 (Resolution 07-11764) (the "Original Agreement") for the Citywide Lawn Maintenance ('Project'); and

WHEREAS, the parties desire to amend the Original Agreement by this First Amendment by adding additional sites and increasing the annual agreement amount an additional \$253,201.00, bringing the total annual amount to \$488,761.00, said services being more fully described in Exhibit A, "Scope of Services", which is attached hereto and incorporated herein.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in consideration of the mutual covenants, promises and conditions herein set forth, it is hereby acknowledged and agreed as follows:

- 1. The above recitals are true and correct and are incorporated herein by this Reference.
- 2. The scope of services shall be amended in accordance with Exhibit "A" attached hereto and incorporated herein for the provision of additional services as set forth in the attached Exhibit "A" by the Consultant and increasing the annual agreement amount an additional \$253,201.00 bringing the annual total not-to-exceed \$488,761.00 for Citywide Lawn Maintenance ('Project').
- 3. The terms of this First Amendment shall control and take precedence over any and all terms, provisions and conditions of Original Agreement which might vary, contradict or otherwise be inconsistent with the terms and conditions hereof. All of the other terms, provisions and conditions of Original Agreement, except as expressly amended and modified by this First Amendment, shall remain unchanged and are hereby ratified and confirmed and shall remain in full force and effect.
- 4. This First Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same instrument.
