THIRTEENTH AMENDMENT TO AGREEMENT

THIS THIRTEENTH AMENDMENT (the "Thirteenth Amendment") to the Continuing Contract for Professional Services is made and entered into **this 5th day of December, 2007** by and between the CITY OF NAPLES, a Florida Municipal Corporation (the "City"), and **Tetra Tech, Inc.** - **Hartman and Associates, Inc.** (the "Consultant").

WITNESSETH

WHEREAS, the City and the Consultant entered into that certain Continuing Contract for Professional Services, dated October 1, 2003 (Resolution 03-10207) (the "Original Agreement") for public works/treatment plant processes design services ('Project'); and

WHEREAS, the parties desire to amend the Original Agreement by this Thirteenth Amendment to provide supervisory control and data acquisition (SCADA) system upgrades to the wastewater treatment plant.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in consideration of the mutual covenants, promises and conditions herein set forth, it is hereby acknowledged and agreed as follows:

- 1. The above recitals are true and correct and are incorporated herein by this Reference.
- 2. "Article Four, Compensation" shall be amended in accordance with Exhibit "A" attached hereto and incorporated herein for the provision of additional fees by the Contractor in the amount not-to-exceed \$39,924.23 to provide supervisory control and data acquisition (SCADA) system upgrades to the wastewater treatment plant ('Project').
- 3. The terms of this twelfth Amendment shall control and take precedence over any and all terms, provisions and conditions of Original Agreement which might vary, contradict or otherwise be inconsistent with the terms and conditions hereof. All of the other terms, provisions and conditions of Original Agreement, except as expressly amended and modified by this Thirteenth Amendment, shall remain unchanged and are hereby ratified and confirmed and shall remain in full force and effect.
- 4. This Thirteenth Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same instrument.

Tetra Tech, Inc. (Tt) is pleased to offer this proposal for maintenance of the City's Wastewater Treatment Plant (WWTP) Network system. The extent of the work will consist of the following:

- · Provide installation assistance for installing new network hardware
 - Tetra Tech will assist plant personnel to physically install the network switch equipment.
 - Tetra Tech will need plant assistance with mounting the equipment inside the existing control panels.
- Install & configure new Trihedral VTS Software on client computers, includes 5 computers total.
 - Tetra Tech will provide two software engineers on-site for 32-hours to setup, install, configure and test the new Trihedral software.
 - Enhance Trihedral functionality (includes 24-hours of on-site programming by two Tetra Tech programmers) (Separate trip from above)

Schedule

The services described herein will commence upon receipt of a Notice to Proceed (NTP) from the City. Tt anticipates being able to order the equipment required for installation immediately following issuance of the NTP. Once the equipment has been received at the WWTP, Tt will be prepared to commence the installation, configuring and programming. Based on conversations with suppliers, the equipment should be delivered within 2 weeks of the order date, with installation taking approximately 1 to 2 weeks.



Fees

The professional fee described above will be billed on a lump sum basis, with invoices submitted monthly based on the percent completion of the various tasks, for the work completed during the preceding month. Reimbursable expenses will be a "not-to-exceed" item and are estimated to be \$1,200.00. Reimbursable expenses will be billed monthly with documentation to support the amount requested. The total base fee for this project is \$39,924.23, which includes \$18,065.00 for professional services associated with programming, \$20,659.23 for equipment purchase, and \$1,200.00 for reimbursable expenses.
