AMENDMENT-1 OF LAST RENEWAL OF AGREEMENT

AMENDMENT 1 TO THIS LAST ONE-YEAR RENEWAL is made and entered into this day of July, 2013 by and between the City of Naples and Russells Clambakes and Cookouts.

WHEREAS, the City and the Contractor entered into that certain Agreement for the operating Concession Facilities at Lowdermilk Park, for the City of Naples; and

WHEREAS, the parties desire to extend the Last Renewal of the Original Agreement so that the Contractor will provide said services for an additional four (4) days from an ending date of August 31, 2013 to September 4, 2013 with no price increase; and
