FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT (the "First Amendment") to the Contract for Professional Services is made and entered into this 5th of November, 2008 by and between the CITY OF NAPLES, a Florida Municipal Corporation (the "City"), and Florida Service Painting, Inc. dba Service Painting of Florida (the "Consultant").

WITNESSETH

WHEREAS, the City and the Consultant entered into that certain Continuing Contract for Professional Services, dated May 7, 2008 (Resolution 08-12035) (the "Original Agreement") for Wastewater Treatment Plant Preliminary Channel (s)/Grit Chamber Lining/Coating ('Project'); and

WHEREAS, the parties desire to amend the Original Agreement by this First Amendment to complete the remaining chambers at the Wastewater Treatment Facility Preliminary Treatent / Grit Chamber Building.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in consideration of the mutual covenants, promises and conditions herein set forth, it is hereby acknowledged and agreed as follows:

- 1. The above recitals are true and correct and are incorporated herein by this Reference.
- 2. "Article Four, Compensation" shall be amended in accordance with Exhibit "A" attached hereto and incorporated herein for the provision of additional fees by the Contractor in the amount not-to-exceed \$163,855.58 to complete the remaining chambers at the Wastewater Treatment Facility Preliminary Treatment / Grit Chamber Building.
- 3. The terms of this First Amendment shall control and take precedence over any and all terms, provisions and conditions of Original Agreement which might vary, contradict or otherwise be inconsistent with the terms and conditions hereof. All of the other terms, provisions and conditions of Original Agreement, except as expressly amended and modified by this First Amendment, shall remain unchanged and are hereby ratified and confirmed and shall remain in full force and effect.
- 4. This First Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same instrument.
