

AGREEMENT FOR PURCHASE AND SALE OF GOODS

THIS AGREEMENT FOR PURCHASE AND SALE OF GOODS (the "Agreement") is made this 17th day of December, 2014, by and between **EMERGENCY VEHICLES, INCORPORATED**, whose address is **705 13th Street; Lake Park, Florida 33403-203** ("Seller") and **THE CITY OF NAPLES**, a Florida municipal corporation, the address of which is 735 Eighth Street South, Naples, Florida 34102 ("Buyer"). In consideration of the mutual covenants and agreements hereinafter set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby mutually acknowledged, Buyer and Seller agree as follows:

1. **Description of Goods; Sale and Delivery.** Seller shall sell, transfer, and deliver to Buyer the goods described in the **Bid/Proposal No. GSA GS-30F-0005R** attached hereto and made a part of as **EXHIBIT A** subject to such terms as are set forth in the Bid/Proposal No. and in this Agreement.
2. **Acceptance; Purchase.** Buyer shall accept the goods and pay the total sum of: **\$200,211.00** for the goods in accordance with the terms of this Agreement.
3. **Identification of Goods.** Identification of the goods shall not be deemed to have been made until both Buyer and Seller have agreed that the goods in question are to be appropriate to the performance of this Agreement.
4. **Rate and Time of Payment.** Unless otherwise specified, Buyer shall make payment to Seller for the goods within 30 days after the goods are received by Buyer.
5. **Receipt of Goods.** The goods shall be deemed received by Buyer when delivered to Buyer at **City of Naples, Fire Rescue Department; 355 Riverside Circle; Naples, Florida 34102**. Delivery of the goods to Buyer shall occur on a business day and shall not occur before 8:00 a.m. or after 5:00 p.m. on the delivery day.
6. **Risk of Loss.** The risk of loss from any casualty to the goods, regardless of the cause, shall be on Seller up to the time of receipt of the goods by Buyer at the place of delivery, but only after any proper inspection has been completed without rejection of the goods. Thereafter, such risk shall be on Buyer, including any goods thereafter returned to Seller until their receipt by Seller.
7. **Warranty Against Encumbrances.** Seller warrants that the goods are now free, and at the time of delivery shall be free, from any security interest or other lien or encumbrance.
8. **Warranty of Title.** Seller warrants that at the time of signing this Agreement or at time of delivery, Seller neither knows, nor has reason to know, of the existence of any outstanding title or claim of title hostile to the rights of Seller of the goods.

9. **Product Warranty.** Seller provides general warranties of fitness and general warranties that the goods are free from defects, for 1 year from acceptance of the goods, except as may otherwise be set forth in the Description of the Bid/Proposal, or other attached warranty: Manufacturer's warranty will apply. **Seller shall provide all warranty documentation at time of delivery.**

10. **Right of Inspection.** Buyer shall have the right to inspect the goods at the time and place of delivery, and within 5 business days after delivery, Buyer must give notice to Seller of any claim for damages on account of the condition, quality, or grade of the goods, and Buyer must specify in detail the basis of such claim. The failure of Buyer to comply with these conditions shall constitute irrevocable acceptance of the goods by Buyer.

11. **Procedure as to Rejected Goods.** On receipt of notification of rejection, Seller will immediately arrange to receive back the goods for shipment and return. However, within 5 days, Seller may have an agent inspect such goods for nonconformity; otherwise, such inspection will be made on return to Seller's storage facility. When such goods are confirmed or acquiesced in as nonconforming, Seller will ship conforming goods within 30 days of the notice of rejection unless Buyer earlier notifies Seller to forgo such shipment.

12. **Governing Law.** The parties acknowledge that the transaction that is the subject matter of this Agreement bears a reasonable relation to the State of Florida and agree that the law of the State of Florida will govern their rights and duties. The parties specifically intend that the provisions of Article 2 of the Florida Uniform Commercial Code will control as to all aspects of this Agreement and its interpretation, and that all the definitions contained therein will be applicable to this Agreement except where this Agreement may expressly provide otherwise.

13. **Bid Documents.** The terms and conditions of the **Bid/Proposal No. GSA GS-30F-0005R** attached hereto and made a part hereof shall be incorporated herein as a part of this Agreement.

14. **Notices and Address of Record.** All notices required or made pursuant to this Agreement to be given by Seller to Buyer shall be in writing and shall be delivered by overnight courier, by hand or by the (USPS) United States Postal Service, first class mail service, postage prepaid, return receipt requested, or as otherwise agreed upon and addressed to the following:


Either party may change its address of record by written notice to the other party given in accordance with requirements of this Article.



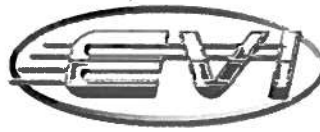

1. TERMS OF PAYMENT: Interim payment of \$47,705.00 is payable upon receipt of chassis at EVI factory or an amount of \$2,433.00 will be added at time of final invoice for floor plan charges.

Late payments are subject to a 12% APR finance charge. A daily finance charge will be added if payment is not received per proposal.

2. DELIVERY SCHEDULE: The emergency vehicle shall be completed approximately 120 to 140 working days from receipt of chassis and approved construction drawings at the Company's factory location in Palm Beach County, Florida.

WARRANTY: Company warrants the new emergency vehicle against defective workmanship and materials. See attached warranty statements for specific coverage and procedure.

CONTINGENCIES: Company shall have no liability to Buyer for any loss or damage arising directly or indirectly from any delay in delivery due to strikes, inability to obtain materials, fires, accidents, or any other causes beyond the Company's control.

DISCLAIMER OF CONSEQUENTIAL DAMAGES: Company expressly disclaims any liability for consequential or incidental damages which may be sustained by Buyer, including but not limited to those arising from the use, inability to use, maintenance or repair of the emergency vehicle, whether under theories of breach of expressed or implied warranty, negligence, strict liability or otherwise.

CANCELLATION: This contract is subject to cancellation by Buyer only upon payment to Company of reasonable cancellation charges, which shall take into account expenses already incurred and commitments made by Company and Company's anticipated profit.

LIQUIDATION DAMAGES: Buyer and Seller agree that if the Buyer requests the work on the vehicle to be temporarily halted or suspended, for any reason that damages would be difficult to ascertain. Therefore, the parties agree to liquidated damages of \$100.00 per day to compensate the Company for expenses, damages and administration.

SEVERABILITY: If any part hereof is contrary to, prohibited by, or deemed invalid under applicable laws or regulations, such provision shall be deemed inapplicable and deemed omitted to the extent so contrary, prohibited or invalid, but the remainder shall not be invalidated and shall be given effect so far as possible.

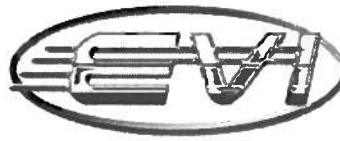

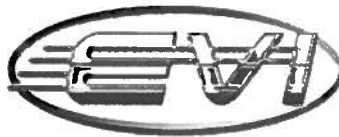

- Paint failures resulting from improper substrate preparation or treatment;
- Paint failures resulting from failure to use the "DuPont System";
- Paint failures resulting from the use of automotive products not manufactured or sold by DuPont;
- Paint failures due to rust or corrosion originating from the substrate;
- Paint failures resulting from work performed by non-DuPont certified refinishers;
- Paint failures caused by improper care, abrasive polishes, cleaning agents, heavy duty pressure washing, or aggressive mechanical wash systems;
- Paint failures caused by abuse, accidents, acid rain, chemical fallout or acts of nature;
- Custom finishes, exotic finishes or decal not applied by the OEM;
- Finishes on vehicles for competitive purposes;
- Paint failures resulting from product misuse or abuse;
- Repairs done over previously refinished areas unless stripped to bare metal or appropriate substrate; and
- Any paint failure that is not inspected by an authorized DuPont representative as set forth in the Claims Procedure section.

NOTE: Surety Bond, if a part of the sale of the vehicle, to which this limited warranty is provided, applies only to the General One Year Warranty for such vehicle, and not to any other warranty made by EVI or any EVI Supplier.

IV. NOTICE

This warranty applies only to defects discovered and notified to DuPont/EVI within the applicable warranty period. The Owner shall give EVI notice in writing of any defect occurring during the warranty period within thirty (30) days of becoming aware of such defect, specifying the nature of the claimed defect and the date it was discovered.

V. CLAIMS PROCEDURE

In the event a vehicle covered by the DuPont warranty demonstrates evidence of a paint failure resulting from a paint defect set forth above, the vehicle must be inspected by an authorized representative of EVI and DuPont for a determination of whether a paint failure covered by the DuPont warranty exists. Any paint failure determined to result from a paint defect subject to the warranty must be approved and authorized in advance of the work by a DuPont representative, and the work must be performed by a certified DuPont refinisher. If such facility is not readily available, a repair facility under the direct supervision of a DuPont representative would be acceptable. In the event work is covered by this warranty, DuPont will replace the product and, where necessary to effect a repair, provide a reasonable allowance for direct labor costs. The actual labor allowance will be determined by DuPont in its sole discretion. Any paint failure determined to result from any paint defect not covered by the warranty will be the sole responsibility of the owner.

VI. NO OTHER WARRANTY

THERE ARE NO OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING WITHOUT LIMITATION, ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE AND ANY SUCH WARRANTIES ARE DISCLAIMED. YOUR RIGHT TO SERVICE AND REPAIRS ARE EXPRESSLY SET FORTH HEREIN AND ARE YOUR EXCLUSIVE REMEDIES AND NEITHER THE MANUFACTURER NOR ANY OF ITS DISTRIBUTORS SHALL BE LIABLE FOR DAMAGES, WHETHER ORDINARY, INCIDENTAL OR CONSEQUENTIAL. The remedy set for therein shall be the sole and exclusive remedy for any breach of warranty. This warranty runs only to the original owner and is not transferable.

VII. ACCESS TO PREMISES

DuPont and its employees, servants, or agents shall be permitted to enter upon the Owner's premises during the hours of 8:00 A.M. to 5:00 P.M. on normal business days to investigate claims hereunder and to carry out spot checks on the application of the DuPont System. DuPont representatives shall identify themselves to personnel immediately upon arrival at the facility of the Owner.
