

**FIRST AMENDMENT TO AGREEMENT
(SERVICES)**

THIS FIRST AMENDMENT (the "First Amendment") to the Contract for Services is made and entered into this 22nd day of July, 2015 by and between the **CITY OF NAPLES**, a Florida Municipal Corporation (the "City"), and **ALL FLORIDA CONTRACTING SERVICES, LLC**, a Florida Limited Liability Company (the Contractor").

WHEREAS, the City and the Contractor entered into that certain Agreement to furnish Services, dated **May 6, 2015** (the "Original Agreement") (Reference Original Bid No. **ITB 15-033** and Original Clerk Tracking No. **15-00068** for services associated with **Radiators for Water Plant Generators: First Amendment: Article 4.1 Compensation** ('Project'); and

WHEREAS, the parties desire to amend the Original Agreement by this First Amendment so that the Contractor will be provided revisions to the Agreement and pursuant to the terms and conditions contained herein.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in consideration of the mutual covenants, promises and conditions herein set forth, it is hereby acknowledged and agreed as follows:

1. The above recitals are true and correct and are incorporated herein by this Reference.
2. "Article Four, Compensation" shall be amended in the amount of \$48,328.00 for additional services related to the replacement of Water Treatment Plant Generator Exhaust Silencers and compliance with current EPA RICE NESHAP & NSPS regulations for internal combustion engines by the Contractor as indicated in **Attachment A-1 Scope of Services and Basis of Compensation** which is attached and made a part of this First Amendment.
3. The terms of this First Amendment shall control and take precedence over any and all terms, provisions and conditions of Original Agreement which might vary, contradict or otherwise be inconsistent with the terms and conditions hereof. All of the other terms, provisions and conditions of Original Agreement, except as expressly amended and modified by this First Amendment, shall remain unchanged and are hereby ratified and confirmed and shall remain in full force and effect.
4. This First Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same instrument.

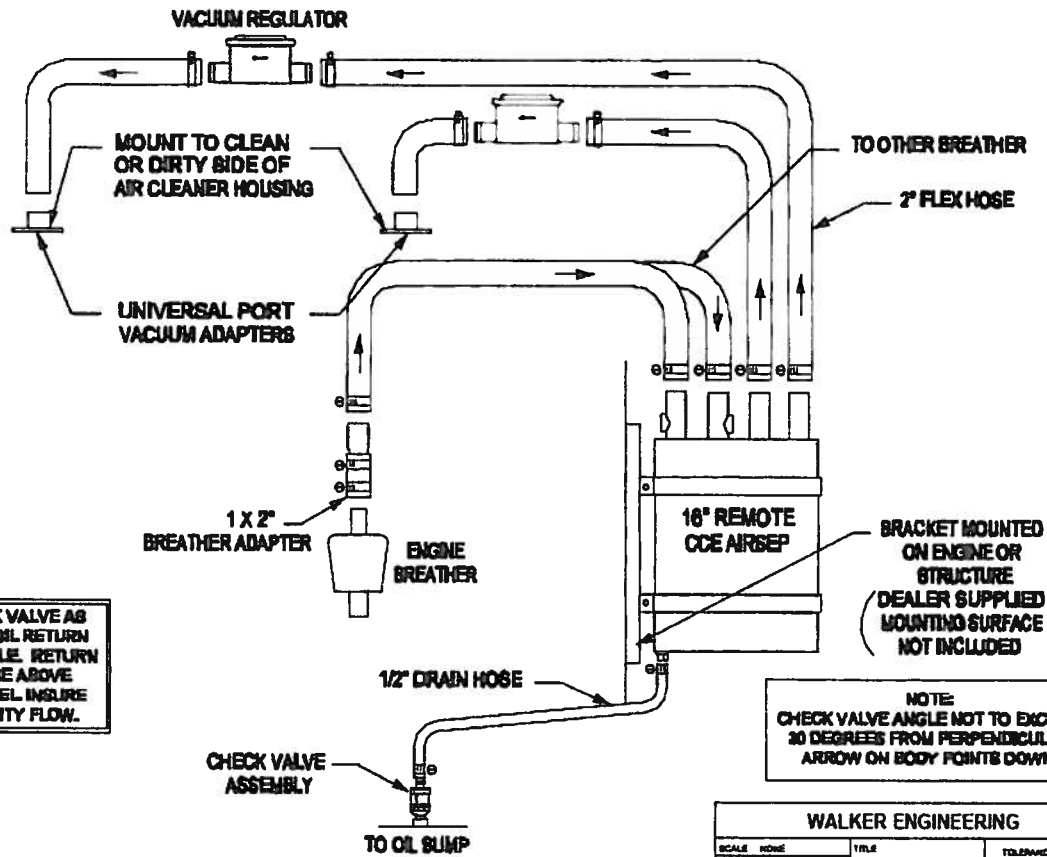

INSTALL CHECK VALVE AS CLOSE TO THE OIL RETURN POINT AS POSSIBLE. RETURN POINT MUST BE ABOVE ENGINE OIL LEVEL. INSURE SMOOTH GRAVITY FLOW.
