

**(TO) TASK ORDER AMENDMENT TO CSC AGREEMENT  
(PROFESSIONAL CCNA SERVICES)**

**THIS TASK ORDER AMENDMENT** (the "Amendment") to the (CSC) Continuing Services Contract for Professional CCNA Services is made and entered into effective the 20<sup>th</sup> day of July 2015, by and between the **CITY OF NAPLES**, a Florida Municipal Corporation (the "City"), and **MARCO SURVEYING & MAPPING, LLC** a Florida Limited Liability Company (the Consultant").

**WHEREAS**, the City and the Consultant entered into that certain Agreement to furnish CCNA Services, on **April 3, 2015** (the "Original Agreement") (Reference Original **RFQ 14-054** and Original Clerk Tracking No. **15-00045**. This **Task Order Amendment** is for **Survey Services associated with Block 7 of the Naples Golf & Beach Club Plat: Task Order No. 15-01-20-31-531040**: ('Project'); and

**WHEREAS**, the parties desire to amend the Original Agreement by this Task Order Amendment so that the Consultant will provide said services pursuant to the terms and conditions contained in the Original Agreement and Amendment herein.

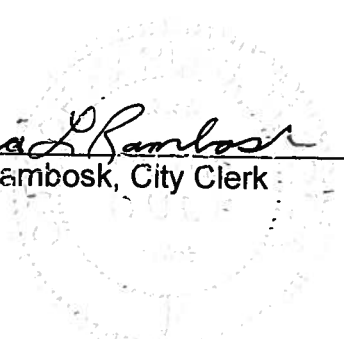
**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, and in consideration of the mutual covenants, promises and conditions herein set forth, it is hereby acknowledged and agreed as follows:

1. The above recitals are true and correct and are incorporated herein by this Reference.
2. "Article Three, Time" is amended to state that this Project Task Order Amendment will be performed and completed within thirty (30) days from the issuance of a Notice-to-Proceed and with a 30-day Project close-out time frame. Project: **Survey Services associated with Block 7 of the Naples Golf & Beach Club Plat.**
3. "Article Four, Compensation" is amended to reflect an increase to the Consultant for this Task Order Amendment in the amount of **\$4,400.00** for the Project as indicated in **Attachment A-1 Scope of Services and Basis of Compensation**, attached and made a part of this Amendment.
4. All other terms, provisions and conditions of the Original Agreement, except as expressly amended and modified by this Amendment, shall remain in full force and effect.
5. This Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same instrument.

Dear Allyson,

Thank you for the opportunity to provide this proposal for survey services. It is based on our phone conversations and emails of July 8, 2015 and revised based upon our conversation of July 16.

**SCOPE:**

**Boundary Survey:**

Marco Surveying & Mapping will perform a boundary survey of Block 7 Naples Golf & Beach Club, Plat Book 2 Page 78, for the purpose of determining the location of the ten foot utility easement that straddles the rear lines of the block. Upon reaching an understanding of the overall block wooden lath will be placed along the perimeter of the 10 foot easement adjacent to the vicinity of the rear corners. Additionally any above ground visible and apparent improvements that fall within the 10 utility easement will be located.

**Fixed Fee: \$4,400**

Deliverables will be in the form of 6 signed and sealed surveys of the block depicting where wooden lath were placed along the easement as well as all located improvements. An AutoCAD file of the survey as well as a PDF of the boundary survey will also be provided.


Marco Surveying & Mapping will complete the above scope within 30 days of the notice to proceed.
