
7. Is a workman's comp exempt certificate acceptable?


Yes, as long as it is issued by the State and there is recognition that all subcontractors must covered for worker's compensation.

Disposal of the excavated material shall be by placement along the west side of the <u>unimproved portion of the 12th Street corridor</u> extending southerly from the City's sewer pump station an approximate distance of 150 feet, more or less, with a nominal width between 10'-15', a height of up to 12" above existing grade and subject to direction of the Project Engineer.






City of Naples THIRD AVENUE NORTH SIDEWALK EXISTING CONDITIONS PLAN






City of Naples THIRD AVENUE NORTH SIDEWALK GRADING PLAN
