• **PROPOSAL PERFORMANCE & PAYMENT BONDS**

A Proposal Security Bond shall be submitted with the final proposal, if the total proposal is greater than \$125,000.00, in an amount equal to at least five percent (5%) of the total amount of the final proposal, or the equivalent in the form of a certified check or money order made payable to the City of Naples, Florida. Upon the award of the proposal to the successful proposer, both proposal performance bond and the payment bond will be required in the amount of one hundred percent (100%) of the price specified in the contract. Also proof of insurance from the successful proposer is required at the time of award as well.

• **WRITTEN VENDOR QUESTIONS:**

1) Do you have an engineers estimate for this project?

Answer: An engineer's estimate has not been prepared for this project.

2) Do you have an estimated value (Budget) for the subject project and is a bid bond required?

Answer: The capital budget for the project is \$200,000. Proposal Performance & Payment Bonds are required; please refer to the above additional bid excerpt.

• **PRE-BID MEETING GENERAL COMMENTS AND INFORMATION:**

- 1) FDOT permit packets are additionally available for review at the City Clerk's office and the City Streets and Stormwater office.
- 2) Please note there are two separate Notice to Proceed elements for the project.
- 3) All improvements need to be made within the existing FDOT right-of-way. There are no other usable easements as part of the construction scope for the project. Close coordination with the City's engineer and inspector is required for work done within the right-of-way along all property lines. The City's engineer must provide the contractor with final written approval for

the locations of mast-arm foundation, stop bar, crosswalk, pedestrian pedestals, and advanced warning signs.

- 4) Equipment staging area within the Fifth Avenue Parkway may be available subject to permitting in accordance with City Code 08-12282. Additionally, use of the adjacent private property may be available subject to approval of applicable private land owners.
- 5) The City will have final control as to re-use of any on site materials for the project.
- 6) Traffic mast arm shall be painted by the pole manufacturer to color specified by the City.
- 7) Traffic lane restrictions and night work shall comply with FDOT requirements and be subject to City review and approval.
- 8) The two 'NO TURN ON RED' signs to be installed on the new mast arm shall be 30' X 36' (Reference: Bid Item #700-48-18).
- 9) The lump sum cost for Bid Item No. 3 includes all work in both identified FDOT pay items.
- 10) The cost of Bid Item No. 10 includes all work in both identified FDOT pay items.
