Below please find Bid clarifications.

1) Request from Water Solutions Marketing for: 1) Toilet Compartment, and 2) Metal Locker product substitution.

Answer: There is no objection to the acceptance of the submitted product as a vendor for the project.

2) Please verify there are no specifications separate from the plans that pertain to the landscape portion of this project.

Answer: In regard to the landscape question, our code min landscape plans do provide some specifications, particularly on the installation, quality of material, warranty, etc. However, the City of Naples Utilities Standards Manual does provide specifications on restoration by sodding and seeding, and would suggest the contractors reference the applicable sections within your City Specifications Manual also. We have a note on our code min landscape plan that specifically addresses this topic.

3) The folks at McGraw Hill Dodge reports indicate that they cannot list us as a bidder unless they get the information from the Owner. We looked on the City website to determine how to become an official planholder and bidder, but do not see it. What do we need to do to be listed as a bidder?

Answer: There is no official City of Naples plan holder or bidders list. The City of Naples does not provide a plan holder or bidders list to McGraw Hill Dodge. 4) Enclosed with the bid form is "<u>Site-Civil Bid Schedule</u>". With this being covered on your bid tab under division 2000 will it be necessary to include the Stantec cost breakdown with our bid or is this something the low bidder can supplier to you within 5 days of the bid opening?
Answer: The contractor should provide the unit price costs for each of the line items within the Site-Civil Bid Schedule to allow us to evaluate each submitted bid.

5) Please confirm if Horizon Window Blinds are required, and if so, to which windows. **Answer:** Please submit data requesting the substitution in accordance with the Project Manual section 01630 Product Options and substitutions at least 10 days in advance of the bid.

6) Exhibit A, bid documents show pricing requirements for 10 steel bollards. We have located 14, internal and external plus flanged for FE protection. The 3 drawings listed above would seem to contradict each other and we are unable to locate a schedule of bollard size / diameter / footing depth. Can you please confirm which plan takes precedence or issue height AFT, diameter and footing depth for respective bollards?

Answer: Bollards for the building interior and immediate adjacent are detailed on the Architectural and structural drawing. Bollards elsewhere on the site may be detailed and / or specified by the Civil drawings.

7) Additional clarifications on product substitution:

- Access Door supplier, Karp Associates, Inc. is an acceptable manufacturer for the product.
- Drawing A-202 Wall type #1; Revise 1-5/8" studs to be 20 ga. in lieu of 18 ga.
- Drawing A-701 detail 5; Integral color white is acceptable.
- Drawing A-202 Wall types 2, 3 and 4. It is acceptable to alternately frame the walls with diagonal bracing above the ceiling provided all installation comply with stud manufacturers bracing requirements and the diagonals are placed to eliminate interference with HVAC and other trade installations.
- Drawing A-701 Details 12 and 13 Revise the gypsum board thickness to be 5/8" in lieu of 1/2". Clarification; ALL gypsum board on the project shall be 5/8" minimum thickness unless required otherwise by a UL assembly requirement.
- Drawing A-102 Clarification; Shaft Wall UL design U428 shall be the basis for the separation requirement of 1-hour. Height required for the final installation may alter the stud depth and gauge as required by the stud manufacturer span tables and shall be accounted in the bid. There shall be no future cost adjustment for height / stud / size / gauge to complete the final installation. In the event the UL design number is revised due to the stud span the contractor shall so advise the Architect prior to initiation of the work at the submittal phase of the project.
