Below are questions received for clarification of the bid document from the February 4, 2013 pre-bid meeting:

1) Can the truck bodies be made in Canada?

**Answer: There is not a federal Buy American clause in the specifications. However, for emergency parts availability, we are favoring the "Body to Manufactured in the USA." If this is not the case, please indicate exception.**

2) You currently have split frame bodies, are you looking to replace those?

**Answer: No. We are looking for drop frame side-loading body trucks.**

3) Is tire pressure self-monitoring equipment mandatory?

**Answer: Yes. The vendor shall install a Doran 360HD Tire Pressure monitors. If not provided, please indicate as an exception.**

4) The specifications require a side-mounted tool box for rakes / shovels. What are the required dimensions for this?

**Answer: Rakes and shovels can be mounted on the truck by other means. The side mounted tool box has no stated dimension.**
