- **PRE-BID MEETING QUESTIONS AND INFORMATION:**

1) Will you please clarify what are the bonding requirements at the time of proposal submission (January 4th) and post the clarification as an addendum on the website?

If a bid bond is required, it will be so stated in the Bid Specifications. The Bid security is to be a bond provided by a surety company authorized to do business in the State of Florida, or the equivalent in cash, or otherwise supplied in a form satisfactory to the City. The bid bond must be submitted with the bid. When the invitation for bids requires bid security, noncompliance will result in rejection of the bid.

Bid bonds will be returned to all bidders after successful award of contract. Note that failure or refusal of the bidder to enter into the contract with twenty (20) calendar days after receipt of contract will result in damages to the City and bid bond will be forfeited to the City as liquidated damages.

- **WRITTEN VENDOR QUESTIONS:**

1) Is there an engineer's estimate for the above named project?

Please refer to page 13 in the RFP: "No amount of work is or will be guaranteed or implied. The contract(s) to be awarded under this RFP will be annual contracts that will be utilized only in the event that specified projects under \$200,000 consisting of new projects, repair, replacement, and maintenance tasks are issued. As such, no compensation will accrue to the CONTRACTOR unless and until the contract is utilized in anticipation of a requested project. Potential CONTRACTORS are solely responsible for their own costs of developing the proposal associated with this RFP."
