**THE FOLLOWING INFORMATION IS HEREBY INCORPORATED INTO,
AND MADE AN OFFICIAL PART OF THE ABOVE REFERENCED BID.**

Note: the City has a "Utilities Specification and Standards Manual" dated September 2010 that is in place and need to be considered as part of this project. Also, please refer to the drawing specifications for detailed piping replacement requirements for this project.

Below are questions from the non-mandatory pre-bid meeting. The answers are made apart of this bid.

1) Is Alternate 3 in the Bid Schedule required to be stainless steel?

Answer: Yes. Please see the revised bid schedule below, Exhibit A.

2) Will new filter platforms be required?

Answer: The walkway/platform around the existing equipment is to be removed and/or replaced depending upon specific model and manufacturer of filter to be installed. If the new equipment requires platforms for access, per manufacture's recommendation, then the Contractor shall provide new platforms, per manufacture's recommendations. The cost of which shall be included in the Contractor's bid. A filter manufactured by WestTech, Inc. will not need an elevated platform for access.

3) Will equivalent filters be considered?

Answer: Any alternates must meet all requirements of the bid documents including "The MANUFACTURER shall also be able to show experience and operating installations for dewatering lime softening from similar type treatment plants in the State of Florida for five (5) years."

4) What is the project cost estimate / value?

Answer: Project is budgeted at \$800,000.

5) What is the project time frame, and what is the material lead time?

Answer: All work included in the Contract Documents shall be substantially complete within two hundred forty (240) days and finally complete within two hundred seventy (270) days after the date when Contract Times commence to run. Material lead time must be coordinated with the manufacture to meet this schedule.

6) How often is the City processing sludge from the filters?

Answer: Sludge processing ranges from 4 days per week (off season/summer) to 6 days per week (peak season/winter) depending on demand.

7) Will the concrete floor drain need to be replaced as part of the project?

Answer: The floor drains (ground level) need to be replaced, the cost of which shall be included in the Contractor's bid.

8) Is there any underground piping that needs to be replaced as part of the project?

Answer: No below ground piping is to be replaced. Piping on ground level may need to be replaced to no deeper than the bottom of the concrete floor to replace drains.

9) There are currently two electrical control panels, how is the replacement of these going to be handled?

Answer: Two control panels (not one) are to be installed to replace the two existing control panels.
