**The following clarifications are issued for the referenced solicitation:**

1) What is the current contract price for the bid?

**ANSWER: The current contract for these services was approved in an annual amount of \$574,329.**

2) Do you need a Collier County contractor's license for this bid?

**ANSWER: The vendor is responsible for knowing all applicable licensing that is required to operate within the City and Collier County.**

3) What is the current per cubic yard contract rate?

**ANSWER: The current contract solicited pricing based on a specific number of units outlined within the previous bid (002-09) for horticulture collection services. The current contract unit rate is \$7.89 per single family residential site per month; and \$7.89 per multi-family site per month (unlimited volume for each site). A copy of the current contract's bid schedule has been provided below:**

1. Provide once-a-week horticultural debris to 5,821 single-family residents and 200 vacant lots.

Per Unit/month	Annual Cost
\$ <u>7.89</u>	$\times 12 \times 6,021 =$ \$ <u>570,068.28</u>

NOTE: Costs include collection at City sites and disposal.

2. Provide horticultural collection service to approximately 45 multi-family shared sites.

Per Site/month	ANNUAL COST
\$ <u>7.89</u>	$\times 12 \times 45 =$ \$ <u>4,260.60</u>

NOTE: Costs include collection at City sites and disposal.

TOTAL ANNUAL COST FOR ALL COLLECTIONS: \$ <u>574,328.88</u>

The new specifications outlined in City bid 052-13 has been modified from previous specifications in which the specifications require the bidder to provide a flat monthly rate to provide services to accommodate 6,400 single family locations, 45 multi-family sites, and approximately 200 vacant lots. There are two pricing options being requested. Option "A" pricing allows for an unlimited volume of debris to be collected per site. Option "B" pricing provides for a cap of two (2) cubic yards per site.

- 4) How did you arrive at the tonnage figures based on the yardages listed?

**ANSWER:** Please refer to Specifications Section 6.2. The tonnage figures are estimates based on the number of cubic yards collected from October 2011 through September 2012. These figures have been provided in order to illustrate volumetric trends collected for a complete contractual year. These figures are also consistent with the volumes of debris collected during the current year (2013).

- 5) Is there a local bid preference?

**ANSWER: No.**

- 6) As the current hauler for the past (5) years, can we use this as a reference.

**ANSWER: Yes.**

- 7) Will the City of Naples accept our bid on flash drive instead of a CD?

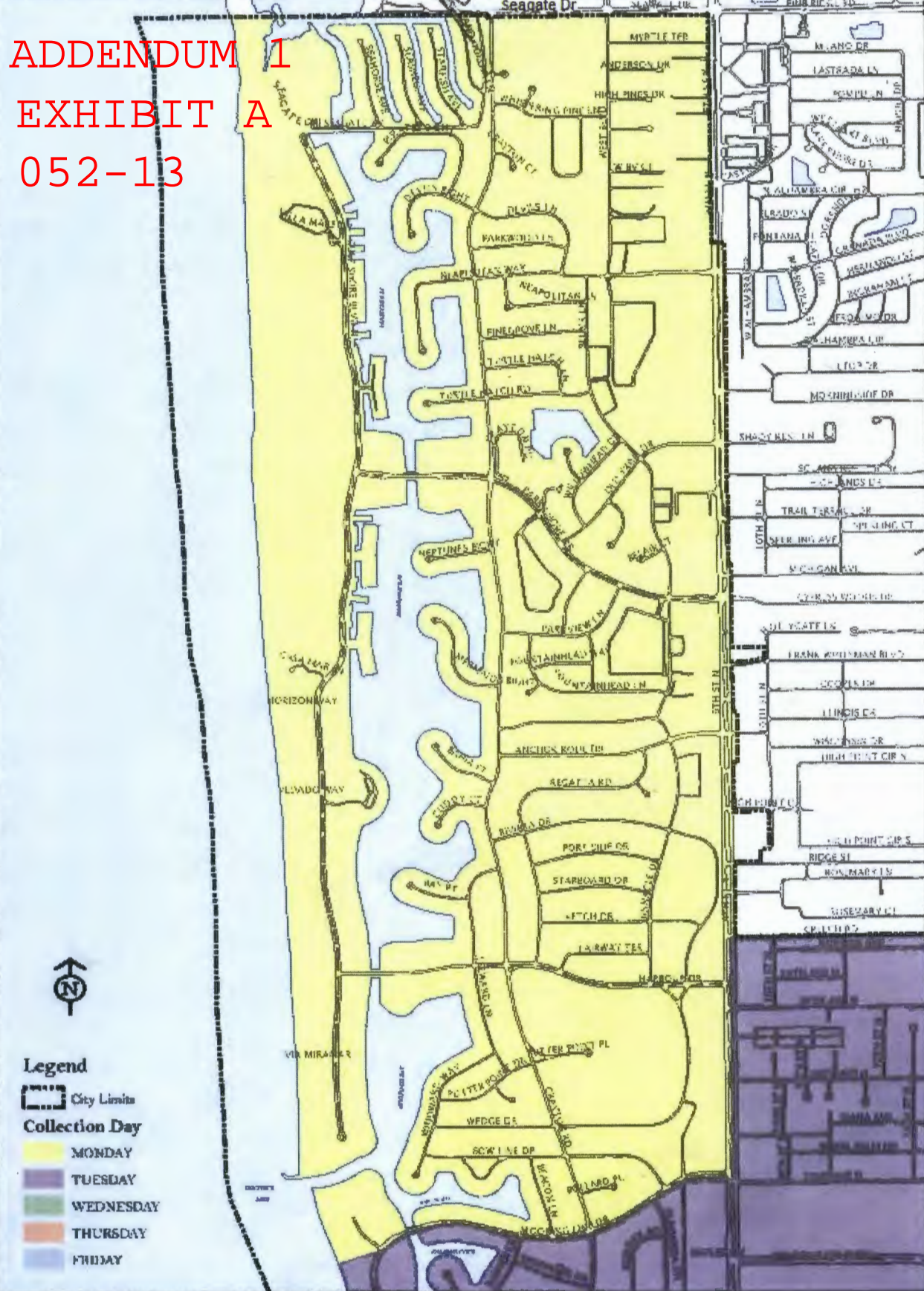
**ANSWER: Yes. The drive must be clearly marked and identified.**

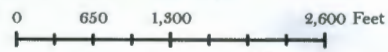
