The following clarifications are issued as an addendum identifying the following changes for the referenced solicitation:

- 1. The Terms of Contract found on page 21 of the bid document are hereby modified to read as follows:**

TERMS OF CONTRACT

Start and end dates

Project will start on or about March 10, 2014 and must be **substantial** completed ~~within~~ by **May 30, 2014** ~~from the Notice to Proceed~~ and with A1A construction invoice **due** immediately after final inspection.

- 2. Pursuant to Section 8 of the General Conditions on page 3 of the bid document:**

“Any manufacturers' names, trade names, brand names, information and/or catalog numbers listed in a specification are for information and not intended to limit competition. The proposer may offer any brand for which he is an authorized representative, which meets or exceeds the specification for any item(s).” This Section takes precedent over Section E of the Special Conditions on page 12 of the bid document as along a product justification is explained in the bid Proposal.

- 3. Project site plan will be provided in Addendum 2 for this solicitation as soon as it becomes available.**

4. The following are answers to written questions submitted as of the date of this Addendum.

- We received your invitation for the Wheelchair Accessible Play Structure project. Is there a budget or estimated cost for this project?

Answer: The project “amount not to exceed” is found on page 16 of the bid document.

- Is your intent to award this to a Playground Contractor or a General Contractor? Or either?
