Attached in Exhibit B please find the updated Sheet E-101 with a device label correction. In Nitrification Tank 2B, Device Label 2A/SSP is changed to 2B/DOP.

The following clarifications are issued as an addendum for the referenced solicitation:

- The new PLC, CTP and PWR enclosure sized scaled from sheet E-101 indicate a 20 inch wide enclosure. Preliminary panel design indicates 48 inches required for the CTP and 42 inches for the PLC. What is the maximum enclosure size permissible?
 ANSWER: The PLC, CTP, and PWR enclosures shown on Sheet E-101 are Not to Scale. The enclosures shown of Sheet E-101 were depicted for location ONLY. Sheet E-002, right hand side notes, clearly defines the sizing requirements for each of the enclosures.
- Section 167482.05 B specifies SCADA screens for process tanks and clarifiers for which is no instrumentation is included in this project. Is this correct / required?

ANSWER: The following corrections are: Section 16748, 2.05, B, 1. Process Tanks Aeration Basins Overview Section 16748, 2.05, B, 2. Individual Clarifies Aeration Basins (update ex. Screen)

3) Does the existing SCADA license have sufficient points to accommodate the project? ANSWER: Yes. The City holds the license and it can accommodate all points of this project.

4) We would also like to know if you might have a list of Electrical Contractors that are bidding this project whom we can submit our instrumentation bid to or are you looking for a direct instrumentation bid?


