The following clarifications are issued as an addendum for the referenced solicitation:

- 1) I am trying to find out what is on the project as related to:
- Any auto flushers
 - Any sampling stations
 - Any blow-offs

ANSWER: All project details and specification are found in the 14-031 EXHIBIT B - Technical Data - Reclaimed Water Option T2 Construction Plans that are part of the original bid document.

- 2) There are areas where the proposed utility is shown to go over and under existing utilities. Are we to assume these offsets can be performed by deflection of the pipe or with fittings?

ANSWER: Yes.

- 3) The plans refer to removal of soil cement road base. Is there an estimated qty or depth to account for?

ANSWER: No.

- 4) Can a bid item be added to address this item so all bidders are bidding the same qty?

ANSWER: No.

- 5) Will a casing be required for the services that will be directional drilled under asphalt?

ANSWER: No.

6) Does this contract require the connection to existing meters? Refer to detail on C-7.

ANSWER: \$150.00.

8) Will the MOT need to be signed by a P.E?

ANSWER: No.

9) Are there any MBE/WBE goals or requirements associated with this project?

ANSWER: No.

10) Are there any specific wage rates on these projects?

ANSWER: This project is not subject to Davis Bacon requirements and no wage determinations or wage rates are specified.

11) Asphalt and base restoration is dependent on the existing thicknesses but there is no information on what is existing. Can you clarify what we are to assume for existing asphalt base thickness.

ANSWER: The minimum thicknesses are provided on Detail Sheet C-5 "Trench Backfill in Paved Roadways".

12) Bedding depends on the Seasonal low GWT. Please provide what that elevation is.

ANSWER: Seasonal low GWT varies, but in general it should be assumed that the seasonal low GWT will be encountered during pipeline installation for the majority of the projects.

13) Is there a geotechnical report that can be provided for both projects?

ANSWER: No.
