RESOLUTION 13-13307

A RESOLUTION AMENDING THE FISCAL YEAR 2012-13 BUDGET AS ADOPTED BY ORDINANCE 12-13175 TO FUND THE COST OF RIGHT-OF-WAY IMPROVEMENTS, INCLUDING CONSTRUCTION OF A SIDEWALK, CURBING, AND ASSOCIATED PAVING, ALONG WITH THE INSTALLATION OF LANDSCAPING AND IRRIGATION, IN THE 500 BLOCK OF PARK STREET, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City adopted a budget for Fiscal Year 2012-13 in September 2012 by Ordinance 12-13175; and

WHEREAS, there is a missing link in the sidewalk connecting the City owned parking lot at 610 Park Street and 5<sup>th</sup> Avenue South; and

WHEREAS, on May 1, 2013, the Naples Community Redevelopment Agency unanimously voted to approve the improvements in the right-of-way in the 500 block of Park Street to complete the sidewalk connection; and

WHEREAS, the improvements include construction of a sidewalk, curbing and associated paving, along with installation of landscape and irrigation; and

WHEREAS, to construct this project, a budget amendment is required to increase the Streets Fund Road Repair line item (Account 390.6565.541.46-12) by appropriating \$20,000 from the Contingency Account of the General Fund (Account 001.7272.582.99-01) which has a current balance of \$342,100;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NAPLES, FLORIDA:

**Section 1.** That the Fiscal Year 2012-2013 Budget as adopted by Ordinance 12-13175 is hereby amended to fund the cost of right-of-way improvements, including construction of a sidewalk, curbing, associated paving, along with the installation of landscaping and irrigation in the 500 block of Park Street.


**Section 2.** That the Streets Fund Road Repair line item is increased by \$20,000 by appropriating funds from the Contingency Account of the General Fund.


**Section 3.** This resolution shall take effect immediately upon adoption.


