Meeting of 4/6/16****RESOLUTION 16-13781**

**A RESOLUTION AMENDING THE FY 2015-16 BUDGET ADOPTED BY RESOLUTION 15-13699 BY APPROPRIATING FUNDS FROM GENERAL FUND CONTINGENCY FOR THE REMOVAL OF SIGNS AND PILINGS AND THE PURCHASE AND INSTALLATION OF NEW SIGNS AND PILINGS PERMITTED IN MOORINGS BAY BY THE FLORIDA FISH AND WILDLIFE CONSERVATION COMMISSION, INCLUDING THOSE REQUIRED TO ENFORCE ORDINANCE 16-13751, WHICH ESTABLISHED CERTAIN BOATING RESTRICTED AREAS AND VESSEL SPEED REGULATIONS IN MOORINGS BAY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS,** the City of Naples adopted a budget on September 16, 2015 via Resolution 15-13699; and

**WHEREAS,** on November 24, 2015, a letter from the Florida Fish and Wildlife Conservation Commission ordered the City to remove the IDLE SPEED – NO WAKE regulatory markers that had been installed in Moorings Bay pursuant to a previously nullified City vessel regulation ordinance; and

**WHEREAS,** the City then applied for and received a permit to install informational signs indicating "YOU ARE RESPONSIBLE FOR YOUR WAKE – RECKLESS/CARELESS OPERATION STRICTLY ENFORCED" on the current pilings in Moorings Bay; and

**WHEREAS,** the IDLE SPEED – NO WAKE signs have been removed and the informational signs installed; and

**WHEREAS,** on February 3, 2016, City Council adopted Ordinance 16-13751 establishing certain boating-restricted areas regulating vessel speeds in Moorings Bay; and

**WHEREAS,** the installation of pilings and approved signage is necessary to enforce the boating restricted areas and vessel speed regulations established in Moorings Bay by Ordinance 16-13751; and

**WHEREAS,** the unaudited balance of the General Fund Contingency account is \$80,050; and

**WHEREAS,** an appropriation of \$35,000 from the General Fund Contingency account is required to complete this project;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NAPLES, FLORIDA:**

**Section 1.** That the FY 2015-16 budget of the City of Naples, adopted by Resolution 15-13699, is hereby amended to provide sufficient funds for the removal of signs and pilings and the installation of new signs and pilings permitted by the Florida Fish and Wildlife Conservation Commission, including those required to enforce Ordinance 16-13751 which established boating restricted areas regulating vessel speeds in Moorings Bay.

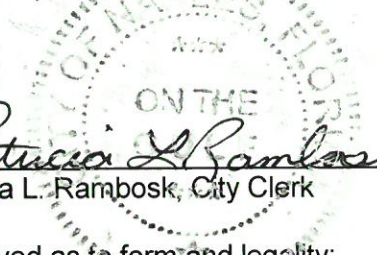
**Resolution 16-13781**

**Section 2.** That \$35,000 is appropriated from General Fund Contingency to the General Fund Non-Departmental Operating Expenditures Account for this purpose.

**Section 3.** This resolution shall become effective immediately upon adoption.
