RESOLUTION 2017-13940

A RESOLUTION AMENDING THE FISCAL YEAR 2016-17 BUDGET ADOPTED BY RESOLUTION 16-13853 BY APPROPRIATING FUNDS FROM THE GENERAL FUND CONTINGENCY FOR POLICE AND FIRE SCHEDULING AND PAYROLL SOFTWARE, AND FOR FIRE-RESCUE MOBILE EYES SOFTWARE, AND FOR POLICE PUBLIC SAFETY ANNUAL SOFTWARE MAINTENANCE AND SUPPORT; AND PROVIDING AN EFFECTIVE DATE.

- WHEREAS, the City of Naples adopted a budget on September 21, 2016 via Resolution 16-13853; and
- WHEREAS, the City of Naples Police and Fire-Rescue Departments' current scheduling and payroll software does not operate with Windows 10 and is not integrated with Tyler Munis; and
- **WHEREAS,** an upgrade to Workforce Telestaff in the amount of \$12,000 will enable the software to be used and payroll to be exported to Tyler Munis; and
- WHEREAS, Fire-Rescue's current inspection process software is outdated and inefficient; and
- WHEREAS, acquiring software, with an estimated cost of \$17,000, that follows the Fire and Safety codes for Occupancy Classifications, delivers inspection documents electronically and includes National Fire Protection Association (NFPA) codes will enhance efficiency and reporting; and
- WHEREAS, the City of Naples Police and Fire-Rescue Departments purchased a public safety software package from Tritech Software Systems, formerly VisionAir, in December 1997, which included modules for mobile units, records management, fire, and computer-aided dispatch; and
- WHEREAS, annual maintenance in the amount of \$62,163 is required to maintain Tritech Software Systems; and
- WHEREAS, staff recommends the budget be amended for software and maintenance for a total of \$91,163;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NAPLES, FLORIDA:

- **SECTION 1.** That the FY 2016-17 budget of the City of Naples, adopted by Resolution 16-13853 is hereby amended by appropriating \$91,163 from the General Fund Contingency
- SECTION 2. This resolution shall become effective immediately upon adoption
