IN CONSIDERATION OF APPROVAL BY THE CITY OF NAPLES, OF THIS APPLICATION, THE APPLICANT AGREES TO THE FOLLOWING:

- All house sewers from the property line to the building are the property and responsibility of the property owner.
- All stoppage in house sewers from sewer gravity main to property line, except those caused by broken pipe or roots from city-owned trees, are the responsibility of the property owner.
- Where stoppage between the sewer gravity main and the property line is caused by broken pipe or roots from city-owned trees, the city will clean and repair that section between the property line and the sewer gravity main.
- No person shall make connection of roof downspouts, foundation drains, areaway drains, or other sources of surface runoff or groundwater to a building sewer or building drain which in turn is connected directly or indirectly to the public sanitary sewer.
- Each resident or business shall have an individual lateral, with 2 clean-outs: One 6-inch clean-out located at the property line and another 3 feet from the building foundation. All house connections to the wastewater gravity main shall be 6-inch minimum size.
- The sewer connection via a sewer lateral shall be performed by a licensed plumber.
- Additional charges of the sewer connection and/or sewer lateral may apply and will be billed accordingly to actual labor, equipment and materials provided.
- I agree to comply with current City ordinances and other pertinent regulations.
