IN CONSIDERATION OF APPROVAL BY THE CITY OF NAPLES, OF THIS APPLICATION, THE APPLICANT AGREES TO THE FOLLOWING:

- Water service applied for, is subject to the continuing availability of raw water Supply and Treatment Plant capacity, and subject to all requirements of law.
- The water meter and backflow assembly shall always remain accessible to utilities personnel for inspection, testing, and maintenance.
- **The water meter must not be moved or storage without prior approval by the city utility director.**
- There is a one time application fee, installation, relocation, and removal fee; and a daily fee (which shall commence after 90 days upon installation of the meter). A deposit will be collected with the application. The deposit will be returned minus all unpaid above-stated charges and any charges due to damage to the meter and backflow assembly.
- The current water rates will apply for the water recorded by the meter plus a 25 percent surcharge.
