

FINAL PUBLIC NOTICE

The Federal Emergency Management Agency (FEMA) has received the subgrant application for City of Naples, Cambier Park due to damages in Hurricane Irma (DR-4337-FL PW 5588). Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for this project under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published October 06, 2017 for Hurricane Irma. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

- Proposed Work and Purpose:** Applicant removed and replaced approximately 1460 SF of gypsum sheetrock, 800 SF of hardwood flooring, 800 SF of vinyl flooring, 8 wooden base cabinets, 36 LF of wainscoting, and metal roof ridge caps, 2 lighting fixtures and bulbs, 16 exterior fans, 8 tiki hut thatched roofs, 120 FT of fence, top/bottom rail and posts to restore the facility to pre-disaster condition in order to provide open space and outdoor recreational activities to the local community.
- Project Alternatives:** The alternative that has been considered is the no action alternative. This alternative is not feasible as the park provides multiple outdoor recreational activities, including open space, and a Community Center for the surrounding community. With the no action alternative, continued negative impacts on health of the residents, and the community may be experienced due to the loss of these opportunities. This alternative provides a level of service that supports the community's basic needs and expectations for outdoor recreational opportunities and the cost of relocating the facilities would not be practicable at this time.
