Acknowledgement of Naples Regulations

Application is hereby made to obtain a permit to do the work or installation as indicated. I certify that no work has commenced prior to issuance of a permit and that all work will be performed to meet the standards of all laws regulating construction in this jurisdiction. The permit or application fees may have additional fees imposed for failing to obtain permits prior to commencement of construction.

The approved permit and/or permit application expires if not commenced within 180 days from the date of issuance. If an application is not pursued in good faith within 180 days of the application date it will be withdrawn. The permittee further understands that only licensed contractors may be employed, and the structure will not be used or occupied until a Certificate of Occupancy/Completion is issued. By signing this permit application, I agree that I have been retained by the owner/permittee to provide contracting services for the trade for which I am listed. I understand it is my responsibility to communicate all information about the application to the property owner. Furthermore, it is my responsibility to notify the Building Department should I no longer be the contractor responsible for providing said contracting services. I further agree that I understand that the review and issuing of this permit does not exempt me from complying with all City Ordinances, State & Federal Regulations. It is further understood that the property owner/permittee is the owner of the permit and that a signed request from the property owner is required to withdraw/cancel a permit and/or a permit application.
