This Task Order Amendment is for services associated with Professional Construction Administrative Services: Task Order No. 16-01-20-33-15K04: Article Three Time and Article Four Compensation. - 3. "Article Four, Compensation" is amended to reflect an increase to the Consultant for this Task Order Amendment in the amount of \$5,046.00 for the Project as indicated in Attachment A-1 Scope of Services and Basis of Compensation, attached and made a part of this Amendment.
- All other terms, provisions and conditions of the Original Agreement, except as expressly amended and modified by this Amendment, shall remain in full force and effect.
- 5. This Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same instrument.



Presentation meetings to the Owner and/or City agencies. Project team meetings as requested by the owner for coordination with owner's separate consultants.
