

**(TO) TASK ORDER AMENDMENT TO CSC AGREEMENT  
(PROFESSIONAL CCNA SERVICES)**

**THIS TASK ORDER AMENDMENT** (the "Amendment") to the (CSC) Continuing Services Contract for Professional CCNA Services is made and entered into effective the 14th day of April 2016, by and between the **CITY OF NAPLES**, a Florida Municipal Corporation (the "City"), and **TKW CONSULTING ENGINEERS, INC.**, a Florida Profit Corporation (the Consultant").

**WHEREAS**, the City and the Consultant entered into that certain Agreement to furnish CCNA Services, on **April 6, 2015** (the "Original Agreement") (Reference Original **RFQ 14-054** and Original Clerk Tracking No. **15-00049**. **This Task Order Amendment** is for services associated with **Fleischmann Park Concession Building Stair Replacement: Task Order No. 16-02-09-17-546340** (the 'Project'); and

**WHEREAS**, the parties desire to amend the Original Agreement by this Task Order Amendment so that the Consultant will provide said services pursuant to the terms and conditions contained in the Original Agreement and Amendment herein.

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, and in consideration of the mutual covenants, promises and conditions herein set forth, it is hereby acknowledged and agreed as follows:

1. The above recitals are true and correct and are incorporated herein by this Reference.
2. "Article Three, Time" is amended to state that this Project Task Order Amendment will be performed and completed within 60-days from the issuance of a Notice-to-Proceed and with a 30-day Project close-out time frame. The Project: **Fleischmann Park Concession Building Stair Replacement**.
3. "Article Four, Compensation" is amended to reflect an increase to the Consultant for this Task Order Amendment in the amount of **\$6,590.00** for the Project as indicated in **Attachment A-1 Scope of Services and Basis of Compensation**, attached and made a part of this Amendment.
4. All other terms, provisions and conditions of the Original Agreement, except as expressly amended and modified by this Amendment, shall remain in full force and effect.
5. This Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same instrument.

TKW Consulting Engineers, Inc. (TKW) is pleased to submit this proposal to provide a design for removal and replacement of the deteriorated concrete staircase at the south end of the Concession Building at Fleischmann Park in Naples. TKW visited the site on February 3, 2016 to observe the existing conditions. TKW will evaluate options and design a replacement staircase using cast-in-place concrete, precast concrete, or fabricated aluminum, and will prepare a letter recommendation to the city. On city concurrence of the recommended materials, TKW will design the staircase and prepare signed and sealed construction drawings for removal and replacement of the staircase.

TKW will provide limited post-design services that may include evaluation of contractor proposals, review of contractor submitted shop drawings and RFI, and a site visit during construction and a final inspection. TKW will complete the evaluation, design, and bid-ready construction drawings within 45 days from city's notice to proceed with the work.

Our fee to complete this work is \$6,590 as summarized in the attached task-based fee budget.
