

**(TO) TASK ORDER AMENDMENT-01 TO CSC AGREEMENT
(PROFESSIONAL CCNA SERVICES)**

THIS TASK ORDER AMENDMENT-01 (the "Amendment") to the (CSC) Continuing Services Contract for Professional CCNA Services is made and entered into effective the 22nd day of April 2016, by and between the **CITY OF NAPLES**, a Florida Municipal Corporation (the "City"), and **TKW CONSULTING ENGINEERS, INC.**, a Florida Profit Corporation (the Consultant").

WHEREAS, the City and the Consultant entered into that certain Agreement to furnish CCNA Services, on **April 6, 2015** (the "Original Agreement") (Reference Original RFQ 14-054 and Original Clerk Tracking No.15-00049. Clerk Tracking No. 15-00185 is assigned to the issuance of the Original Task Order 16-01-09-17-15I31. This Task Order Amendment-01 is for services associated with **Evaluation of 1998 Police Building: Task Order No. 16-01-09-17-15I31-01** (the 'Project'); and

WHEREAS, the parties desire to amend the Original Agreement by this Task Order Amendment so that the Consultant will provide said services pursuant to the terms and conditions contained in the Original Agreement and Amendment herein.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in consideration of the mutual covenants, promises and conditions herein set forth, it is hereby acknowledged and agreed as follows:

1. The above recitals are true and correct and are incorporated herein by this Reference.
2. "Article Three, Time" is amended to state that this Project Task Order Amendment will be performed and completed within 90-days from the issuance of a Notice-to-Proceed and with a 30-day Project close-out time frame. The Project: **Evaluation of 1998 Police Building**.
3. "Article Four, Compensation" is amended to reflect an increase to the Consultant for this Task Order Amendment-01 in the amount of **\$1,750.00** for the Project as indicated in **Attachment A-1 Scope of Services and Basis of Compensation**, attached and made a part of this Amendment.
4. All other terms, provisions and conditions of the Original Agreement, except as expressly amended and modified by this Amendment, shall remain in full force and effect.
5. This Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any part whose signature appears thereon and all of which shall together constitute one and the same instrument.

TKW Consulting Engineers, Inc. (TKW) is pleased to submit this proposal to provide design and installation information for new roof truss tiedowns in the Emergency Operations Center and Police and Emergency Services Building at 355 Riverside Circle (1998 Police Building).

Our recent inspection identified a number of locations where the roof trusses were not tied down to the precast hollow-core roof slab and the City now wishes to install the tiedowns. TKW will design the new tiedowns to meet the current Florida Building Code requirements for a Category 3 storm event, which is consistent with our evaluation of the existing building. TKW will provide signed and sealed documentation so that a contractor or City staff can install the tiedowns. Our fee to complete this work is \$1,750.00.
